Snapshot of Number of Certified Peer Support Specialists

The following table presents the number of certified substance use and mental health peer support specialists across each state, district, and territory in the United States as reported on the date listed in Column 4 of the table. Data sources for the report include state approved certifying entities and state behavioral health agencies as listed in Column 5.

State, districts, and territories may offer separate certifications for substance use (SU) peer specialists and mental health (MH) peer specialists, or they may offer one certification (Integrated) for both peer specialists and mental health peer specialists. Column 2 indicates which type of certification is available in each state, district, and territory. See the January 2023 Requirements for Peer Support Specialist Training and Certification in the U.S. report by the Peer Recovery Center of Excellence for more information.

The information in the table is listed alphabetically by state, district, and territory.

*Denotes numbers that were reported as cumulative (total certifications granted) rather than current count (current active certifications).

Data Collection

Data was collected between August 2023 through July 2024 from state approved certifying entities and state behavioral health agency websites where available. When online data was not available, staff at the Peer Recovery Center of Excellence contacted representatives of the state approved certifying entities and state behavioral health agency websites via email to obtain data. Data is valid as of the date indicated in Column 4.

Gathering this data posed significant challenges due to the variability in certification bodies between states and the infrequent availability of up-to-date information. Additionally, the number of certified peer support specialists is continually evolving as more individuals achieve certification.


