### Introduction

The Peer Recovery Center of Excellence (PR CoE) was funded by the Substance Abuse and Mental Health Services Administration (SAMHSA) in 2020 to provide training and technical assistance to the substance use peer recovery field. As part of supplemental funding provided in 2023 to increase the number of Recovery Community Organizations able to bill insurance and be reimbursed for peer recovery support services, this report was developed to provide a state-by-state analysis of Medicaid reimbursement specifically for peer support services, including peer recovery support services for substance use disorders and mental health peer support services. This report provides a national overview of:

- · which states offer Medicaid reimbursement specifically for peer support services,
- · reimbursement rates for one-on-one and group peer support services,
- funding authority types and selections by each state,
- billing codes and modifiers used by each state to specify peer support services, and
- · recommendations.

The landscape of mental health and substance use disorder services in the United States has seen a significant transformation since 2007 when the Centers for Medicare and Medicaid Services (CMS) provided crucial guidance allowing states, territories, and the District of Columbia to include peer support services under the umbrella of Medicaid.

This move was not just a recognition of the effectiveness of peer support services, but also a testament to the growing acknowledgment of the invaluable role that individuals with lived experience play in the recovery journeys of others (Smith, 2007). Peer support services, rooted in evidence-based practices, continue to become an integral part of the nation's healthcare framework.

This report explores the nuances of this transformative policy shift, providing a comprehensive national overview of states that offer Medicaid reimbursement for peer support services. Within these pages, we survey the intricacies of state reimbursement processes and procedures, shedding light on the mechanisms that enable the integration of peer support services into the Medicaid system. Through meticulous research and analysis, this report aims to not only illuminate the current landscape but also to provide valuable insights into the varied approaches adopted by states and U.S. territories.

A crucial aspect explored in this report is the Medicaid funding authorities that states leverage to deliver peer support services. This report breaks down some of the complexities associated with reimbursement mechanisms. This report also examines the methods employed by states, offering a detailed account of billing codes, modifiers, and the associated rates, both for one-on-one and group peer support services.

Furthermore, this report provides special notes and recommendations that have emerged from compiling the data. By presenting a comprehensive overview of the current landscape, this report equips readers with a nuanced understanding of the Medicaid reimbursement for peer support services, empowering policymakers, the recovery workforce, and advocates with the knowledge needed to further enhance the accessibility and effectiveness of mental health and substance use services in the United States.

# Overview of Medicaid

In 1965, Medicaid was signed into law, authorized by Title XIX of the Social Security Act along with Medicare as public insurance programs. Medicaid was designed to provide health coverage for low-income people, including children parents, pregnant women, seniors, and people with disabilities.

Medicaid enrollment often flexes over time — it is designed to expand if needs rise during economic downturn or condense during economic upturn. It is federally overseen by Health and Human Service's Centers for Medicare & Medicaid Services and administered independently by the states (Medicaid.gov, 2023). All states, the District of Columbia, and the U.S. territories have Medicaid programs. It is jointly funded by the federal government and the states (Center on Budget and Policy Priorities, 2020).

While the federal government mandates certain guidelines and restrictions, each state manages their own Medicaid program, including who is eligible and which additional services beyond what is federally required are covered. This results in varied coverage and reimbursement rates across the country (Medicaid.gov, 2023).

Some of these federal requirements include mandatory coverage for certain services such as hospital and physician care, laboratory and X-ray services, home health services, and nursing facility services for adults. Additional services are covered as well, and those are determined by each state. All states cover prescription drugs. Most state programs, but not all, also cover dental care, vision services, hearing aids, and personal care for qualifying seniors and people with disabilities (Center on Budget and Policy Priorities, 2020).

The majority of Medicaid spending across the nation pays for acute care services such as hospital care, physician services, and prescription drugs. The remainder is accounted for in long-term care services and supports such as nursing homes or home health services (Center on Budget and Policy Priorities, 2020). Nationally, Medicaid contributes 18% of all healthcare spending (Rudowitz et al., 2023).

Most Medicaid beneficiaries (those enrolled in and using Medicaid as their health insurance provider) are covered through private managed care plans (Center on Budget and Policy Priorities, 2020). These managed care organizations (MCOs) work as a liaison between state Medicaid agencies and Medicaid beneficiaries to ensure the delivery of health benefits and additional services through contracted arrangements. Beneficiaries pay the MCO a fee per month to participate.

MCOs can also be helpful to states by managing cost, utilization, and quality of health services (Medicaid.gov, 2023). For beneficiaries not a part of an MCO, the state's Medicaid program pays healthcare providers directly for covered services delivered. Healthcare providers are not required to participate in Medicaid, and not all do (Center on Budget and Policy Priorities, 2020).

Medicaid effectively improves access to care and improves health outcomes to our most vulnerable populations (Rudowitz et al., 2023). In 2014, the Affordable Care

Act (ACA) induced major coverage expansions. Since then, the number of uninsured decreased from 45 million to 29 million. For many low-income workers, other coverage options from themselves and their families are inaccessible because they cannot afford to purchase through their job or on the individual market.

Not all states adopted ACA's Medicaid expansion, which has led to several health outcome comparison studies. For states that adopted the expansion, and therefore increased enrollment and coverage, we have consistently seen rises in adults with a personal physician, preventative care, and regular care for chronic conditions compared to non-expansion states. Other studies have indicated medical debt decreases, improvement to overall self-reported health, reductions in positive depression screenings among adults, improved chronic disease symptom management, and even better access to credit which leads to more secure housing (Center on Budget and Policy Priorities, 2020).

## The 2007 Guidance Letter from the Center for Medicare and Medicaid Services

In 2007, the Centers for Medicare and Medicaid Services (CMS) released a letter to the states' Medicaid directors providing guidance for states to allow Medicaid coverage of peer support services. Additionally, this letter served as recognition that recovery is possible for people living with challenges related to mental health or substance use. Further, the letter recognized that peer support services are an evidence-based model and an important component of the states' delivery of behavioral health services. CMS has basic requirements for states to receive federal reimbursement for Medicaid. States must:

- 1. Name the Medicaid funding authority to be used for coverage and payment.
- 2. Describe the service, the provider of the service, and the provider's qualifications in full detail.
- 3. Describe utilization review and reimbursement methodologies (i.e., the procedures that ensure services are delivered as described and the processes for billing and reimbursement).
- 4. Base reimbursement on a unit of service, which is usually a time allotment for the service, typically 15 minutes (Smith, 2007; Medicaid and CHIP Payment and Access Commission [MACPAC], 2018).

The 2007 CMS letter designated that peer support services are delivered by a qualified peer support specialist who self-identifies as having lived experience of — and is in recovery from — a mental health and/or substance use challenge. Peer support services are delivered to Medicaid beneficiaries who are living with mental health and/or substance use challenges.

CMS identified three core components that states must fulfill to offer Medicaid reimbursement for peer support services.

- Supervision. Supervision must be provided by a state-defined, "competent mental health professional." States define the scope, duration, and amount of supervision.
- 2. Care Coordination. Peer support services are to be delivered within the context of the Medicaid beneficiaries' individualized plans of care developed through

- person-centered planning processes. The Medicaid beneficiary should be able to lead and direct the design of the plan that reflects their selected needs, preferences, and goals.
- Training and Credentialing. Peer support specialists are to be trained and certified as defined by each state. Training should address specific peer support competencies. A peer support specialist should be able to demonstrate the ability to support recovery. Further, continuing education requirements should be instituted.

Per the 2007 CMS letter, states' Medicaid agencies have discretion to define: 1) the service delivery system, 2) medical necessity criteria, 3) the amount, duration, and scope of service, and 4) how to pay for the services.

### **Medicaid Funding Authorities**

This section briefly defines and describes Medicaid Funding Authorities (i.e., the different Medicaid reimbursement options available through Title XIX of the Social Security Act) utilized to reimburse peer support services under each states' Medicaid program.

States have the option to reimburse peer support services through multiple Medicaid Funding Authorities, including the state Medicaid program or Medicaid Waivers.

### State Medicaid Programs

State Medicaid programs (also referred to as the State Plan) are jointly funded by federal government and states; each state establishes their own provider payment rates (i.e., how much is reimbursed for services; Medicaid.gov, 2023). States pay for services through fee-for-service (that is, the states' Medicaid offices receive claims from providers and directly reimburse the providers for services) or managed care arrangements (states contract with managed care entities to receive the claims and reimburse providers; MACPAC 2023a).

### **Medicaid Waiver Programs**

States may also utilize designated Medicaid Waiver programs. These special types of funding authorities implemented under Medicaid law allow states to apply for exemptions from certain Medicaid requirements. These exemptions are referred to as waivers. The waiver requests may address eligibility requirements, provider and service options available to beneficiaries, or requirements all services are offered statewide (MACPAC, 2023b).

### **How Waivers Work**

Medicaid Waiver programs allow states to choose groups of people with particular needs and health conditions to receive tailored healthcare options at home or within the community. Examples include waivers for care relating to developmental disabilities, traumatic brain injuries, AIDS, and substance use challenges. Each state develops and manages its own waiver programs, so rules, eligibility criteria, and billing vary (Sullivan, 2021).

All waivers are funded by a mix of state funds and a federal share that is determined

by each state's waiver program and per capita income relative to the national average. This means that the federal government pays a larger portion of costs in states with lower per capita incomes relative to the national average than in states with higher per capita incomes relative to the national average.

Reimbursement rates for services under a waiver are negotiated between the provider and the state program. Most often, a rate or an amount of billable time is agreed upon, setting a precedent for future services provided (Penrod, 2022). Lastly, each state is responsible for establishing a regular auditing process for assessing effectiveness, efficiency, and accuracy (Medicaid Waiver Compliance Review, 2018).

### Types of Medicaid Waiver Programs

Waivers that are used to pay for peer support services include the following:

1915(b) Waivers. This waiver program is generally funded for two-year cycles. This waiver permits states to implement service delivery models that may limit choice (e.g., managed care) or are limited to a geographic region. These waiver programs must demonstrate that they are cost effective and efficient.

1915(c) Waivers. This waiver program is generally funded for three-year cycles. This waiver authorizes states to provide home and community-based services as an alternative to institutional care. Usually, the beneficiaries of this waiver program are those deemed to need institutional care, and the waiver provides support to live in the community. These waiver programs cannot cost more than the estimated federal spending amount without the program (referred to as cost neutrality). To achieve cost neutrality, states may establish programs for specific populations, set limits for the number of people enrolled, or set limits for costs.

1915(i) Waivers. This waiver program is similar to the 1915(c) waiver; however, states do not have to demonstrate cost neutrality and beneficiaries do not have to meet the standard of requiring institutional care. States can use these waivers to target specific populations. States cannot set limits on the number of people enrolled in the program and services must be offered state-wide.

1115 Waivers. This waiver program is for experimental or pilot demonstration projects. These special projects start out with funding for five years and may be extended for three years or up to 10 years in rare instances. These waiver programs must demonstrate cost neutrality. The 1115 Waiver program is intended to provide states with flexibility to experiment with different approaches to operation, delivery, or payment (MACPAC, 2023b).

The specific funding authorities utilized nationally to reimburse for peer support services will be described in the *Medicaid Funding Authorities Utilized to Reimburse for Peer Support Services* section of this report.

# Understanding Medicaid Billing and Reimbursement Terminology

For most states, the Medicaid reimbursement methodology requires that the providers of services file claim forms to the state's Medicaid program administrator for reimbursement of services. These claim forms are how providers bill the states for Medicaid services. Claim forms are special documents that include the services provided and diagnoses. On this form, the services are labeled with alphanumeric billing codes. The providers that file the claim then receive payment for the service at the reimbursement rate established by each state's Medicaid authority (MACPAC, 2018).

### Peer Support Specialist Medicaid Billing Codes

According to the National Library of Medicine (ND), the Centers for Medicare and Medicaid Services produce a collection of standardized codes that represent all medical procedures, supplies, products, and services, including behavioral health services. This coding system is called the Healthcare Common Procedure Coding System (HCPCS). In this report, you will see this acronym used to refer to the codes utilized by providers to bill for peer support services.

The specific code for peer support services is H0038 (CMS, 2017). However, some states have designated other codes for peer support services, as will be shown in the *Billing Codes and Modifiers* section of this report.

### **Billing Code Modifiers**

States often add modifiers to the HCPCS codes. Modifiers are two-character codes (any combination of letters or numbers) that communicate specific circumstances about the services provided; modifiers, like billing codes, are standardized within HCPCS (American College of Emergency Physicians, 2023). For instance, many states add the two letters HQ to signify that the peer support service was in a group setting and not provided one-on-one. The billing codes and modifiers utilized by states for peer support services are described in the Medicaid Billing Codes and Code Modifiers Utilized by the States section of this report.

Reimbursement rates refer to the set amounts states pay providers for each service. Reimbursement rates are established in each states' approved Medicaid state plan. These rates vary between states and may vary within states depending upon specific circumstances. Medicaid reimbursement rates are described in the Reimbursement Rates for Medicaid Peer Support Services section of this report.

Many states offer Medicaid reimbursement for peer support specialists providing services billed under billing codes other than those designated for peer support services. This report focuses only on Medicaid reimbursement for peer support services as described in the 2007 CMS letter.

# Peer Support Specialist Certification

As described in the previous section, states must establish training and certification requirements for peer support specialists to provide coverage and receive federal reimbursement for peer support services. This section of the report provides an overview of states' peer support specialist certifications and is summarized from a report recently published by PR CoE: Comparative Analysis of State Requirements for Peer Support Specialist Training and Certification in the United States (2023). This report details training and certification requirements for mental health and substance use peer support specialists for each of the 50 states, the District of Columbia, and the U.S. Territories.

PR CoE found that 49 states and federal territories (including the District of Columbia) offer training and certification for peer support specialists. One state, South Dakota, and the five U.S. Territories do not currently offer training and certification for peer support specialists. Of the 50 states that offer training and certification, 34 offer single, integrated peer support specialist certification for individuals with lived experience in substance use and/or mental health recovery. Fourteen other states offer separate certifications based on the type of behavioral health lived experience (that is, lived experience of mental health or substance use). One state (Hawaii) recognizes only mental health peer support specialist certification, and one state (New Hampshire) recognizes only substance use peer support specialist certification.

## National Model Standards for Peer Support Certification

In 2023, the Substance Abuse and Mental Health Services Administration (SAMHSA) collaborated with federal, state, tribal, territorial, and local partners—including peer specialists — to develop the National Model Standards for Peer Support Certification, inclusive of substance use, mental health, and family peer certifications. As noted in the overview, "These National Model Standards closely align with the needs of the behavioral health peer workforce, and subsequently, the overarching goal of the national mental health strategy. SAMHSA's National Model Standards for Peer Support Certification were not developed as a substitute for any state certifications, but as guidance for states, territories, tribes, and others to promote quality and encourage alignment and reciprocity across often disparate state peer support certifications. The National Model Standards are designed to accelerate universal adoption, recognition, and integration of the peer workforce, and to strengthen the foundation set by the peer workforce, reinforced by the Core Competencies, and implemented by our state, local, and tribal partners." (SAMHSA, 2023).

### Methods

To explore which states offer peer support services under the Medicaid program. the data from the 50 U.S. states, the District of Columbia and five U.S. territories including American Samoa, Guam, Northern Marianas Islands, Puerto Rico, and the Virgin Islands were gathered and compiled by the Peer Recovery Center of Excellence and the Texas Institute for Excellence in Mental Health at the University of Texas-Austin.

The sources for this report were resources available from the states' behavioral health agency websites as of October 22, 2023. Examples of these resources include Medicaid provider and billing manuals, documents announcing coverage for peer support services, and Medicaid fee schedules.

### This report identifies:

- · whether states, territories, and the District of Colombia offer reimbursement to cover peer support services under their Medicaid Programs.
- states' reimbursement of one-on-one and group peer support services,
- states' reimbursement of mental health and substance use peer support services,
- the Medicaid reimbursement rates,

- the Medicaid funding authorities states utilize to reimburse for peer support services.
- the use of the peer support services H0038 billing code or other billing codes designated by the states to specify peer support services, and
- · modifiers that are added to the Medicaid billing codes and what these signify.

Please note that links are likely to change as the resources and manuals are updated periodically. All data in this report are compiled from a review of states' documents as listed above. While this report provides information directly from states' documents, the data in this report would benefit from direct confirmation from the states' agencies that oversee Medicaid. Further, the data in this report represent documented Medicaid billing and reimbursement practices, not utilization of peer support services under the Medicaid program.

## **Findings**

Of the 56 U.S. states, territories, and the District of Columbia, 48 currently offer reimbursement for peer support services under the Medicaid program.

The five territories (American Samoa, Guam, Northern Marianas, Puerto Rico, and U.S. Virgin Islands) and one state, South Dakota, have not met the Medicaid requirement of establishing training and certification for peer support specialists, and therefore do not reimburse peer support services through Medicaid (Smith, 2007).


Vermont and Wisconsin have established training and certification for peer support specialists, but do not offer Medicaid reimbursement for peer support services.

### States' Medicaid Reimbursement for One-on-One Peer Support Services

Of the 48 states that offer Medicaid reimbursement for peer support services, all offer reimbursement for one-on-one peer support (Figure 1).

#### Of these 48 states:

- 38 offer Medicaid reimbursement for both mental health and substance use peer support services.
- five states offer Medicaid reimbursement for only mental health peer support services, and
- five states offer Medicaid reimbursement for only substance use peer support services.



Data Availability for Medicaid Reimbursement Rates for One-on-One Peer Support Services

Of the 48 states that offer Medicaid reimbursement for one-on-one peer support services, 45 have known fee for service reimbursement rates.

Florida, Michigan, and Tennessee offer Medicaid reimbursement. However, reimbursement rates could not be found in the available documents for Florida or Tennessee, and Michigan provides peer support services through Certified Community Behavioral Health Clinics (CCBHCs), and the state pays a flat rate to these clinics for all services provided. Additionally, although Massachusetts offers reimbursement for both mental health and substance use peer support services, reimbursement rates could only be found for one-on-one mental health peer support services.

Structure for Medicaid Reimbursement for One-on-One Peer Support Services

34 of the known 45 states have one-on-one reimbursement rates for both mental health and substance use peer support services.

- 19 states combine billing for both services under the same Medicaid billing codes and reimbursement rates.
- 15 states reimburse for both but separate billing by using different billing codes (one state), adding a modifier to the billing code (13 states) to designate mental health or substance use peer support services, or by different reimbursement rate only (one state).

Table 2 identifies which states combine reimbursement for mental health and substance use one-on-one peer support services, differentiate reimbursement, or reimburse for only mental health or substance use one-on-one peer support services.

### Medicaid Reimbursement Rates for One-On-One Peer Support Services

This section will summarize the Medicaid reimbursement rates for one-on-one peer support services. All rates reported are adjusted based on a 15-minute billing interval. For states with multiple reimbursement rates for one-on-one peer support services, the minimum and maximum rates are presented.

For all states that reimburse for one-on-one peer support services, the rates range from \$7.34 to \$221.25.

This section is organized as follows:

- A. States (19) that combine reimbursement billing for one-on-one mental health and substance use peer support services.
- B. States (15) that reimburse for both services but separate billing.
- C. States that reimburse for only mental health (6) or substance use (5) one-on-one peer support services.

A. Medicaid Reimbursement Rates for States that Combine Billing for One-on-One Mental Health and Substance Use Peer Support Services

Of the 19 states that combine Medicaid billing for one-on-one mental health and substance use peer support services:

- 16 have one rate for one-on-one peer support services.
- Three have multiple reimbursement rates.
  - The rates for Arizona and Wyoming rates vary based on the funding authority utilized (e.g., fee-for-service, or managed care organization).
  - Arkansas' rates varied based whether the service was in person or virtual.

The reimbursement rates range from \$7.36 to \$23.09.

B. Medicaid Reimbursement Rates for States that Reimburse for Both One-on-One Mental Health and Substance Use Peer Support Services but Separate Billing

Of the 15 states that reimburse for both one-on-one mental health and substance use peer support services but separate billing:

- Six states have a single reimbursement rate that is utilized for both mental health and substance use peer support services.
- Georgia and Oklahoma have multiple reimbursement rates but use the same range of rates for both mental health and substance use peer support services.
  - Georgia's rates vary based on location of service and education level of the certified peer support specialist (e.g., with or without a bachelor's degree).
  - Oklahoma's rates vary based on whether the service is in-person or virtual (e.g., via telephone or computer).
- California and New York have multiple reimbursement rates and use different rates for mental health and substance use peer support services.

- California's rates vary based on the county where services are provided and the funding authority utilized.
- New York's rates vary depending on whether the service is provided upstate or downstate, by funding authority, by location of service, and by program for services.
- Minnesota, Illinois, and Oregon have one rate for substance use peer support services and multiple rates for mental health peer support services.
  - Minnesota's mental health peer support services rates vary by level of certification held by the peer specialist.
  - Illinois' mental health peer support services rates vary by location of service.
  - Oregon's mental health peer support services rates vary by location of service.
- Alabama and Missouri have one rate for mental health peer support services and multiple rates for substance use peer support services.
  - Alabama's substance use peer support services rates vary by population provided support and program for services.
  - Missouri's substance use peer support services rates vary based on whether the service is in-person or virtual (e.g., via telephone or computer).

- Five states have a single rate.
- The District of Columbia has multiple reimbursement rates that vary by the population receiving support.



### States' Medicaid Reimbursement for Group Peer **Support Services**

Of the 48 states that offer reimbursement for peer support services, 26 states offer reimbursement for group peer support services. (Figure 2).

- 19 offer reimbursement for both group mental health and substance use peer support services.
- Three states offer reimbursement for group mental health peer support services
- Four states offer Medicaid reimbursement for group substance use peer support services only.



Data Availability for Medicaid Reimbursement Rates for One-on-One Peer Support Services

Of the 26 states that reimburse group peer support services, 23 have known reimbursement rates. Although states' documents suggested Idaho, Oregon, and Utah reimburse for group peer support services, no reimbursement rates could be found.

Structure for States that Have Reimbursement Rates for Group Peer Support Services

Eighteen of the known 23 states have group reimbursement rates for both mental health and substance use peer support services.

- 11 states combine reimbursement for both under the same Medicaid billing code.
- Seven reimburse for both but separate billing by using different billing codes (three states) or adding a modifier to the billing code (four states) to designate group mental health or substance use peer support services.
- Two states have rates for group mental health peer support services only.
- Three states have rates for group substance use peer support services only.

Table 9 identifies which states combine reimbursement for group mental health and substance use peer support services, which reimburse for both but separate billing, and which reimburse for group mental health or substance use peer support services only.

### Medicaid Reimbursement Rates for Group Peer Support Services

This section will summarize the known Medicaid reimbursement rates for group peer support services. All rates reported are adjusted based on a 15-minute billing interval. For states with multiple reimbursement rates for group peer support services, the minimum and maximum rates are presented.

For all states that have known reimbursement rates for group peer support services, the rates range from \$1.26 to \$49.17 for 15 minutes per person in the group. It should be noted that states have varying maximum numbers of Medicaid beneficiaries that can be in any group session.

This section is organized as follows:

- A. States (11) that combine reimbursement for mental health and substance use peer support services.
- B. States (7) that reimburse for both group mental health and substance use peer support services but separate billing.
- C. States that reimburse for only mental health (2) or substance use group peer support services (3).

A. Medicaid Reimbursement Rates for States that Combine Reimbursement for Group Mental Health and Substance Use Support Services

Eleven states combine Medicaid reimbursement billing and rates for group mental health and substance use peer support services.

- · Nine states have one rate.
- Arizona and Wyoming have multiple rates.
  - The rates for Arizona and Wyoming both vary based on the funding authority utilized (e.g., fee-for-service, or managed care organization).

The group rates range from \$1.26 to \$9.32.

Of the seven states that reimburse for both group mental health and substance use peer support services but separate billing:

- Three states have a single reimbursement rate that is utilized for both mental health and substance use peer support services.
- Georgia has multiple reimbursement rates but use the same range of rates for both mental health and substance use peer support services.
  - Georgia's rates vary based on location of service and education level of the certified peer support specialist (e.g., with or without a bachelor's degree).
- California has multiple reimbursement rates and uses different rates for mental health and substance use peer support services.
  - California's rates vary based on the county where services are provided, and the funding authority utilized.
- Alabama and Rhode Island have one rate for mental health peer support services and multiple rates for substance use peer support services (Table 11).
  - Alabama's rates vary by population provided support and program for services.
  - Rhode Island has different rates related to different group activities.

# Medicaid Funding Authorities Utilized to Reimburse for Peer Support Services

### Identifying the Funding Authorities Utilized

As noted in the introduction section of this report, states may select from multiple funding authorities to reimburse peer support services through Medicaid, including:

- the Medicaid state plan administered as fee-for-service (FFS; reimbursement directly by the state) or contracted through a managed care organization (MCO),
- the 1915 Medicaid waiver programs, or
- the 1115 Medicaid demonstration waiver programs.

The authors of this report examined states' documents to identify which funding authorities the states utilize to reimburse for peer support services, including available State Plan documents (e.g., approved state plan amendments for waiver programs, Medicaid manuals, and states' administrative codes.

Identification of the funding authority was determined by the authors when information about peer support services was listed in the documents that named the funding authority, or when connections were found between documents that listed peer support services and named funding authorities.

While this review attempted to definitively identify the specific funding authorities utilized by each state for peer support services, it is important to note that often this information was not explicitly described in the states documents nor on the websites and was difficult to find.

The authors of this report highly recommend seeking direct input from the states' Medicaid offices to verify which funding authority or authorities are utilized for all states.

Funding Authorities Utilized to Reimburse Peer Support Services

This review identified the Medicaid funding authority utilized to reimburse peer support services for the 48 states that offer reimbursement for peer support services. Of these states:

- 38 states utilize the state plan, administered as fee-for-service directly by the state or through a contract with a managed care organization.
  - 24 administer directly through the state-plan.
  - 30 contract with managed care organizations.

- For Alaska, the specific state plan authority could not be identified definitively because the Medicaid manuals could not be accessed online by the author.
- 19 states utilize the Medicaid waiver programs.
  - Seven utilize 1915 waiver programs, and
  - 13 utilize the 1115 waiver program.

These findings suggest that states use combinations of funding authorities. The remainder of this section will describe the different combinations utilized by the states.

States that Utilize Both the State Plan and Medicaid Waiver Programs

Nine states use both the state plan and Medicaid waiver programs. Table 16 summarizes the different funding authorities utilized. Seven of the states combined the 1115 Waiver with the State Plan, two combined the 1915 waiver with the state plan.

# Medicaid Billing Codes and Code Modifiers Utilized by the States

#### Medicaid Billing Codes for Peer Support Services

The specific Medicaid billing codes for peer support services were available for 48 states and the district and territories. Forty-five states utilize the designated HCPCS billing code, H0038.

Seven states have designated billing codes other than H0038 for peer support services. These states and the designations for the codes are listed in Table 19.

- California and Maryland use other billing codes to designate group peer support services.
- Illinois, Massachusetts, Oklahoma, and Virginia have designated specific peer support codes other than H0038.

#### Modifiers Utilized with the Medicaid Peer Support Services Billing Codes

As noted in the introduction, states utilize designated modifiers with the Medicaid HCPCS peer support specialist billing codes. These modifiers serve a purpose of communicating specificity about the peer support services. In some instances, these code modifiers indicate when different reimbursement rates apply.

Of the 48 states, 39 utilize modifiers with Medicaid peer support services billing codes. The states use a total of 84 different modifiers.

The authors of this report developed categories to organize the modifiers based on the state's descriptions for each modifier. Table 20 lists these categories, the modifiers included in the categories, and the number of states that utilize the modifiers.

States most frequently utilize modifiers designate group peer support services (23 states), substance use peer support services (12 states), peer support services offered virtually or via telephone (12 states), or mental health peer support services (10 states).

## Special Notes, Limitations, & Recommendations

The data compiled for this national overview demonstrates the multiple Medicaid reimbursement methodologies implemented by the states that offer reimbursement for peer support services.

Following are notes and recommendations from the authors:

- The process to compile the data is a limitation. Finding the information was complicated by the differences between how states structure their websites. Finding the information required digging deep into multiple web pages and following resource decision trees that were not intuitively designed.
  - The authors recommend offering state's Medicaid offices the opportunity to provide additional/ correct information.
- Another limitation is that the data represent a point-in-time, and this information is subject to abrupt change. States Medicaid programs undergo revisions to keep pace with the needs of the populace.
  - Recommend finding resources to update the report regularly.
  - Recommend identifying key state Medicaid contacts to incorporate into review process when updating the report.
  - Recommend developing charts of information for state Medicaid staff to verify in review process.
- The Medicaid billing manuals for many states included descriptions of the covered peer support services; an overview of these descriptions and comparison to best practices for fidelity to peer support may be useful. The report did not examine the descriptions of peer support services each state had; this is worth exploration.
- Further, other billing and reimbursement criteria, such as group size limits and annual maximum billing units, should be explored.
- While the information in this report provides the documented practices, the actual utilization of peer support specialists to provide specific peer support services is not described in this report.
